You can send us your requests from now, and we will begin to communicate the result of the selections within three days of sending!

It is possible to attend the event with one artwork in the group exhibition, or at mini solo exhibition with 4 artworks.

REGULATION

Article 1 who can participate.

Artists of all nationalities and any religious beliefs, regardless of age and gender.

Article 2 Target recipients

The theme is free.

All forms of Visual Arts are allowed: sculpture, painting, photography, digital art, graphics and engravings, and all techniques.

Article 3 How to participate

To participate in the selections, ask for the participation form at news.artistsintheworld@gmail.com or at info@artgalleryrome.it and return it filled in by **10 November 2023** attaching one photo. (or 4 photos in case of mini solo exhibition). The artworks must not exceed the size of 80 cm x 80 cm

Article 4 Selection

We select artists who will be distinguished for originality and expressive quality.

No fee is requested to participate in the selection. The selected artists, who confirm their participation in the exhibition, are requested to pay a participation fee:

130 euros for one artwork; 380 euros for four artworks (mini solo exhibition).

10% discount for the artists registered as members of the Artists in the World Events portal at this link: <https://www.artintheworld.net/drupal/content/artists> ; there is also a 10% discount for artists who have already participated in at least one of our events in the last three years. The two discounts can be combined.

The fee allows the artist to have the following facilities, for both group exhibition and mini solo exhibition:

- * CERTIFICATE OF PARTICIPATION (only digital file)
- * ART CATALOG (only digital file)
- * OPENING with drinks and snacks
- * Setting up and dismantling
- * Invitations and communication by mailing list of 95,000 contacts
- * Inserting artistic event sites
- * Graphic Design graphic material Publicity and distribution
- * 5000 Flyers and Poster
- * Guardians
- * Sales assistance
- * Video with pre-show presentation of artists (visible on the network)
- * Video inaugural vernissage (visible on the network)
- * Photos of the event available online

The percentage of 20% is required by the Art Gallery in the event of sale.

Article 5 Presentation of Selected Artworks

At the selected artists for group exhibition and mini solo exhibition, will be asked for the original artworks well packed, on the package they will have to write " [Art Shopping for Christmas 2023](#)" in addition to their name / surname. **The artworks must be received no later than November 27th** (they may be mailed or delivered in person) at the address in Rome that will be communicated once the selection is completed. **The artworks should already be prepared for set up and equipped with central hanger.**

IMPORTANT Only for outside European Union (EU): We must receive the artworks "DUTY FREE/PAID – Custom Cleared".

Article 6 Return of the artworks

It will be possible to directly pick up the artwork at no cost at the address in Rome that will be communicated once the selection is completed.

It is also possible to have the artwork shipped back at the expense of the artist by our trusted courier.

Article 7 Disclaimer

The organizers, although the greatest care of the works received, do not assume any liability for any transport damage, tampering, fire, theft, or other causes during the period of the exhibition, storage, exposure, and stock.

Article 8 Variation of dates

The indicated dates of the event may be subject to change, in case of extraordinary events or situations not dependent from us, in this case we will take care of communicating the changing as soon as possible.

Article 9 Acceptance of Terms

The artist guarantees the originality of the artwork and participating in the exhibition " Art Shopping for Christmas 2023 " implicitly accept all the rules contained in this announcement, and declare to agree with the Application Form requirements.

The participating artist declares to have read these rules and accepts them in all its points, and authorize the use of the personal data/records according to the Italian Law 193/2003 and to the GDPR General Data Protection Regulation (EU) 2016/679 and the publication of Artworks in catalogues or printed paper, electronic databases, publications on websites for specialized press purposes.
